Dear Mr. Guice:

This is in response to Robert Hackney's letter of October 24, 1997 regarding the addition of a small spot paint booth inside your building. This new booth will be added to free the regular paint booth from the time consuming spot painting operation. This new booth will not increase the number of vehicles being painted nor increase the amount of VOC material used. Since there is no increase in emissions no construction permit is needed.

By this letter Air Operating Permit AO17-263471 is amended as follows:

Air Permit Number AO17-263471 is changed to 0330144-001-AO.

Process Description - New Paragraph:

Spot painting, consisting of painting of panels or small area of a vehicle (hoods, trunks, doors, door jams, etc.), is performed in a small, single car cross-flow paint booth. Particulate emissions are controlled by a single wall of paint collecting filters. Filtered air is vented through building roof.

All other specific conditions of this permit remain in effect. This letter shall be attached to and made part of permit 0330144-001-AO. If you have any questions or comments, please contact Armando Sarasua of this office at (850) 595-8364.

This permit is issued under the provisions of Section 403.087, Florida Statutes, and Florida Administrative Code Rules 62-296, 62-297 and 62-4. The above named applicant, hereinafter called Permittee, is hereby authorized to perform the work or operate the facility shown on the application and approved drawing(s), plans, and other documents attached hereto or on file with the Department and made a part hereof and specifically described as follows:

Operation permit for an Auto Body Work and Painting Facility described in the construction permit application, AC17-258054. An average of 50 vehicles per week, mostly passenger cars, are brought in for minor body work and painting. Small dents may be pulled out and filled with body filler, the auto bodies are sanded, and trim and glass are masked. The autos are then painted with a primer coat, a primer sealer coat, an enamel base coat and a color paint coat. Occasionally cars may also have a final coat of sealer. The painting is done inside of a paint booth which exhausts through twin stacks equipped with axial blowers. The newly painted cars are then moved to the bake oven and then to a final drying location for final curing and paint hardening, buffing and touch-ups. The bake oven does not exhaust to the atmosphere, its air is circulated through the paint booth.

SPECIFIC CONDITIONS:

General

1. The attached General Conditions are part of this permit. [FAC Rule 62-4.160]

Operation

2. The maximum allowable operating rate at the paint booth is one car painted within 37 minutes. This is the operating rate at which compliance with standards shall be demonstrated. This rate is approximately equivalent to 3.3 gallons of coatings per hour. [FAC Rule 62-4.070, FAC Rule 62-296.320(1)(a) and construction application]

3. The Auto Paint Shop and Spray Booth may operate, 3,900 hrs/yr, based on three ten hour days and two twenty four hour days per week, and 50 weeks per year. [FAC Rule 62-4.070 and construction application]

4. All containers used for temporary and permanent storage of VOC-containing fluids and/or VOC-soaked cleaning rags shall be tightly covered to prevent vaporization of VOC when not in use. All equipment, pipes, hoses, lids, fittings, etc., shall be operated/maintained in such a manner as to minimize leaks, fugitive emissions and spills of VOC materials. [FAC Rule 62-296.320(1)(a)]

5. Paint booth air filters shall be maintained according to the schedule described in the application section describing pollution controls to maintain proper air flows and cleaning efficiencies. [FAC Rule 62-4.070 and construction application]

Emissions

6. No objectionable odors shall be allowed off plant property. If the Department determines the facility is emitting objectionable odors, the Permittee shall submit an odor remediation plan within 45 days of receipt of written notification from the Department. The plan shall include, but not be limited to, dispersion modeling analysis, strategies to reduce odorous chemicals utilization, and modifications of manufacturing production cycles, manufacturing methods and/or plant exhaust systems. [FAC Rule 62-296.320(2)]

7. Visible emissions shall not be equal to, or greater than, 20% opacity. [FAC Rule 62-296.310(2)]

8. All fugitive dust generated at this site, including but not limited to that from sanding or grinding operations, shall be adequately controlled by existing good housekeeping practices such as periodic sweeping and/or vacuuming of work areas, and closing doors on windy days. [FAC Rule 62-296.310(3)]

Testing

9. Visible Emissions tests are required to show compliance with the standards of the Department. The test results must provide reasonable assurance that the source is capable of compliance at the permitted maximum operating rate. [FAC Rule 62-4.070] 30 minute VE tests shall be conducted in accordance with DEP Method 9. [FAC Rule 62-297.330(1)(b)] Such tests shall be scheduled once each year, prior to September 1 of each year. The Department shall be notified at least 15 days prior to testing to allow witnessing. Results shall be submitted to the Department within 45 days after testing.

Test reports shall comply with F.A.C. Rule 62-297.570, Test Reports. The Department can require special compliance tests in accordance with F.A.C. Rule 62-297.340(2). Other test methods and alternate compliance procedures may be used only after prior Departmental approval has been obtained in writing.

Testing of emissions shall be conducted with the source operating at capacity. Capacity is defined as 90-100% of rated capacity. If it is impractical to test at capacity, then sources may be tested at less than capacity; in this case subsequent source operation is limited to 110% of the test load until a new test is conducted. Once the unit is so limited, then operation at higher capacities is allowed for no more than fifteen days for purposes of additional compliance testing to regain the rated capacity in the permit, with prior notification to the department.

Administrative

10. An Annual Operating Report [DEP Form 62-21.900(4), attached] shall be submitted by March 1 of each year. The attached form shall be reproduced by the permittee and used for future annual submittals.

11. The permittee shall maintain a monthly record of the amounts of each VOC-containing substances used based on beginning and ending inventories, and units painted. As a minimum, these records shall be retained at the facility for the most recent two-year period and made available for department inspection upon request. (FAC Rule 62-4.070, FAC Rule 62-296.320(1)(a))

12. An application to renew this permit shall be submitted prior to November 1, 1999. [FAC Rule 62-4.090]

13. The permanent source identification number for this point source is 10PEN17014401. Please cite this number on all test reports and other correspondence specific to this point source. [FAC Rule 62-297.570]



GENERAL CONDITIONS:

1. The terms, conditions, requirements, limitations, and restrictions set forth in this permit are "permit conditions", and are binding and enforceable pursuant to Sections 403.141, 403.727, or 403.859 through 403.861, Florida Statutes. The permittee is placed on notice that the Department will review this permit periodically and may initiate enforcement action for any violation of these conditions.
2. This permit is valid only for the specific processes and operations applied for and indicated in the approved drawings or exhibits. Any unauthorized deviation from the approved drawings, exhibits, specifications, or conditions of this permit may constitute grounds for revocation and enforcement action by the Department.
3. As provided in Subsections 403.087(6) and 403.722(5), Florida Statutes, the issuance of this permit does not convey any vested rights or any exclusive privileges. Nor does it authorize any injury to public or private property or any invasion of personal rights, nor any infringement of federal, state or local laws or regulations. This permit does not constitute a waiver of or approval of any other Department permit that may be required for other aspects of the total project which are not addressed in the permit.
4. This permit conveys no title to land or water, does not constitute state recognition or acknowledgment of title, and does not constitute authority for the use of submerged lands unless herein provided and the necessary title or leasehold interests have been obtained from the state. Only the Trustees of the Internal Improvement Trust Fund may express state opinion as to title.
5. This permit does not relieve the permittee from liability for harm or injury to human health or welfare, animal, or plant life, or property caused by the construction or operation of this permitted source, or from penalties therefore; nor does it allow the permittee to cause pollution in contravention of Florida Statutes and Department rules, unless specifically authorized by an order from the Department.
6. The permittee shall properly operate and maintain the facility and systems of treatment and control (and related appurtenances) that are installed and used by the permittee to achieve compliance with the conditions of this permit, are required by Department rules. This provision includes the operation of backup or auxiliary facilities or similar systems when necessary to achieve compliance with the conditions of the permit and when required by Department rules.
7. The permittee, by accepting this permit, specifically agrees to allow authorized Department personnel, upon presentation of credentials or other documents as may be required by law, access to the premises, at reasonable times, where the permitted activity is located or conducted for the purpose of:
 - a. Having access to and copying any records that must be kept under the conditions of this permit;
 - b. Inspecting the facility, equipment, practices, or operations regulated or required under this permit; and,

c. Sampling or monitoring any substances or parameters at any location reasonably necessary to assure compliance with this permit or Department rules.

Reasonable time may depend on the nature of the concern being investigated.

8. If, for any reason, the permittee does not comply with or will be unable to comply with any condition or limitation specified in this permit, the permittee shall immediately provide the Department with the following information:

- a. A description of and cause of noncompliance; and
- b. The period of noncompliance, including exact dates and times; or, if not corrected, the anticipated time the noncompliance is expected to continue, and steps being taken to reduce, eliminate, and prevent recurrence of the noncompliance. The permittee shall be responsible for any and all damages which may result and may be subject to enforcement action by the Department for penalties or for revocation of this permit.

9. In accepting this permit, the permittee understands and agrees that all records, notes, monitoring data and other information relating to the construction or operation of this permitted source which are submitted to the Department may be used by the Department as evidence in any enforcement case involving the permitted source arising under the Florida Statutes or Department rules, except where such use is proscribed by Sections 403.73 and 403.111, Florida Statutes. Such evidence shall only be used to the extent it is consistent with Florida Rules of Civil Procedure and appropriate evidentiary rules.

10. The permittee agrees to comply with changes in Department rules and Florida Statutes after a reasonable time for compliance, provided however, the permittee does not waive any other rights granted by Florida Statutes or Department rules.

11. This permit is transferable only upon Department approval in accordance with Florida Administrative Code Rules 62-4.120 and 62-730.300, as applicable. The permittee shall be liable for any noncompliance of the permitted activity until the transfer is approved by the Department.

12. This permit is required to be kept at the work site of the permitted activity during the entire period of construction or operation.

13. The permittee shall comply with the following:

- a. Upon request, the permittee shall furnish all records and plans required under Department rules. During enforcement actions, the retention period for all records will be extended automatically unless otherwise stipulated by the Department.

b. The permittee shall hold at the facility or other location designated by this permit records of all monitoring information (including all calibration and maintenance records and all original strip chart recordings for continuous monitoring instrumentation) required by the permit, copies of all reports required by this permit, and records of all data used to complete the application for this permit. These materials shall be retained at least three years from the date of the sample, measurement, report or application unless otherwise specified by Department rule.

c. Records of monitoring information shall include:

- the date, exact place, and time of sampling or measurement;
- the person responsible for performing the sampling or measurement;
- the date(s) analyses were performed;
- the person responsible for performing the analyses;
- the analytical techniques or methods used; and
- the results of such analyses.

14. When requested by the Department, the permittee shall within a reasonable time furnish any information required by law which is needed to determine compliance with the permit. If the permittee becomes aware the relevant facts were not submitted or were incorrect in the permit application or in any report to the Department, such facts or information shall be corrected promptly.
