As a result, Emissions Unit 002 will be reclassified as an unregulated emissions unit. The facility is located in Taylor County. This permit revision is issued pursuant to Chapter 403, Florida Statutes (F.S.). There **were no** comments received from Region 4, U.S. EPA, regarding the DRAFT/PROPOSED Permit.


