Hi Wanda and Garry,

After my message yesterday, Indian River was requested to run today – just Units 1 and 2 on 100% gas. Therefore, the total number of hours on oil has still not changed since the last update.

Currently, we are not scheduled to run Saturday or Sunday, but we are scheduled to run all three units Monday. If we run as scheduled, Units 1 and 2 will burn 100% gas, but Unit 3 will burn 60% gas (40% oil). This will raise the total number of hours on oil for Unit 3 to about 300. We do not feel like that warrants scheduling a test at this time, but if we receive information on Monday indicating that we will be likely to run for the remainder of the week, we would need to consider setting one up. This will be influenced by the affects of the hurricane on gas availability in the state. If we have to do so, it would most likely be for Unit 3 only and would be during the middle or end of next week. I will continue to keep you posted.

Hello Gary, Wanda, and Jim:

As of today, here is the updated total of oil operating hours for the units at Indian River.

Unit 1 – 92 hrs Unit 2 – 250 hrs Unit 3 – 292 hours

Some oil firing took place throughout this week due to limited gas availability during the storm. However, we are not running today and are not scheduled to run through Monday so we seem to have gotten through the situation without reaching 400 hours on any of the units.

If we did have to run on oil again for several more days, there are two scenarios we are concerned about, however. That we would hit 400 hours on a unit and then:

- 1. Not get called on to run again the rest of the month and then have to burn considerable amounts of oil for testing when the load is not required
- 2. Not have enough days left in the month to enable us to provide 15 days advance notice prior to testing

We would like to know if the Department could work with us on the 15 day notification requirement so we would have the flexibility to attempt to schedule a test while we are running if we do have to run again. This could potentially be on fairly short notice, but I would be willing to send Gary a status update every working day between now and the end of the month so he would know exactly what was going on and could plan a trip over (if he wanted to do so) if a test was scheduled.

We are also willing to discuss the situation by telephone if you require further information to respond to our request.
