Please allow this letter to inform the department that Yellowfin Yachts Inc has moved a portion of its fiberglass manufacturing to a new facility approximately ½ mile away from Yellowfin's main facility.

To better streamline manufacturing and increase efficiencies during the build process, it was imperative that we increase our floor space. This allows Yellowfin to keep all molds inside the facility and reduces the need to move molds around to put into production.

Yellowfin purchased a new facility located at:

Yellowfin started manufacturing in the new facility approximately June 11, 2012 coinciding with model year change.
