Mr. Morrison:

EPD has evaluated the data you sent us, as shown on sheet "dec 05 - nov 06" of the attached spreadsheet. This evaluation is in the format required by the permit, that is, with monthly and consecutive 12-month total gas usages. Your data in therms has been converted to MMBTU because we often deal in those units. However, a limit on therms is also given in the permit, so your therm units are fine.

Our evaluation shows that your highest consecutive 12-month total gas usage is 52,825 MMBTU, well below the permit limit of 148,512 MMBTU/year.

In the future, please keep on site an up-to-date record of both monthly and consecutive 12-month total gas usage as required by permit 0950088-003-AO, condition 10. Lack of up-to-date records may, in the future, be considered a violation of the permit and subject to enforcement action by this agency.
