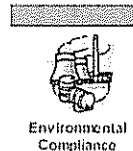



COMMENTS: This inspection was conducted on the concrete batch plant (2 silos and 1 baghouse) and the block plant (1 silo and 1 baghouse, the second silo is damaged and not in use), the rock quarry inspection was not included in this visit. Bill Arlington conducted a 30 minute visible emissions test the concrete batch plant central dust collector. The block plant silo was not tested during my visit. No emissions were observed during my visit.
