Met Abigail Diaz on site, performed facility inspection, checked maintenance logs and fuel consumption and it was in compliance. Fuel consumption is approx 4000 gallons/month. Facility is operating 4-5 days a week and only few hours a day in the morning time. Roads are paved and maintenance yard has no dust problem. Yard is cleaned by Dweeper at least once a week and trucks leave coming and leaving the plant didn't stir up dust. Observed loading of silos - no problem observed.

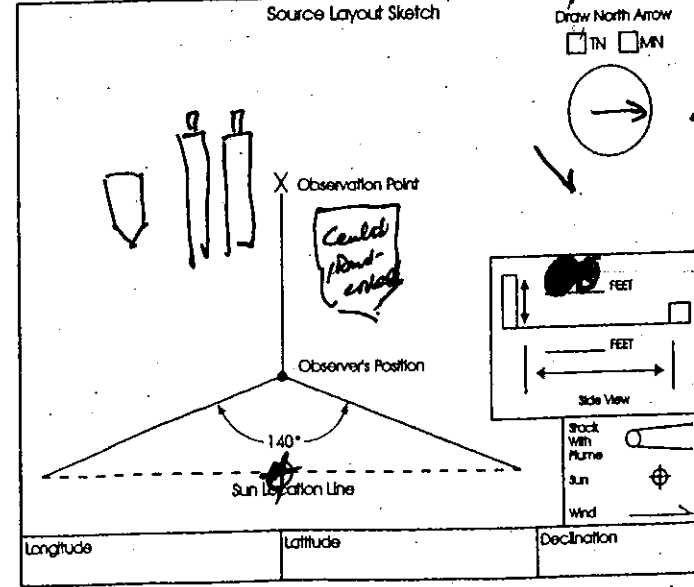
