COMMENTS: Inspector met with Ted Caviglin, Operations Manager and Kevett Mickle from Grove Scientific & Engineering. On January 27, 2010, only one VE was conducted on the Emission Unit 001(1A) (white cement). The VEs for EUs 001 (1B) (grey cement), 005 (4B) and 007 (grey cement) were re-scheduled for the next day, Jan 28, 2010. On January 28, Inspector met with Adam Freeman and Bruno Ferraro from Grove. Due to slow business, the silos were almost full and only one pod from the truck was loaded in each silo . Loading rate for each silo was above minimum rate of 25 tph. Roads are paved, partially wet. No particulate matter was noted leaving the property. No objectionable odors. Due to slow business the rest of the Emission units are not in use.
