**COMMENTS:** In a compliance inspection conducted on 5/10/2012, AQD staff (E.Susky) observed operations at Handcraft Dry Cleaners. The facility has excellent record-keeping and housekeeping. Mr. Chouvalis (owner) was not present for the inspection, but both his sons were on-site and available to answer any questions. Mr. Chouvalis utilizes his FDEP dry-cleaning calendar and keeps accurate records of his leak checks and rolling PERC averages. He keeps his waste manifests and PERC receipts on-site. The REMA vacuum was observed to be in proper containment and the drums of hazardous waste are properly stored in secondary containment and labeled.
