COMMENTS: In a compliance inspection on 07/21/2014, AQD staff (E. Malmstrom) observed operations at Handcraft Drycleaners. Mr. Anthony Chouvalis (owner) was present during the inspection. The facility has excellent housekeeping and record-keeping. The facility has one PERC dry-cleaning machine. Mr. Chouvalis utilizes his FDEP dry-cleaning calendar and had his waste manifests and PERC receipts available for review. On 08/13/2014, AQD staff visited the facility to distribute the environmental compliance sticker for the pilot program initiated by Robert Wong. The facility was closed, however another visit will be made.
