COMMENTS: In a compliance inspection conducted on 3/21/2011, AQD staff observed operations at Mercer Cleaners. The facilityoperates a PERC dry-cleaning machine. Houskeeping is good and recordkeeping is good. However, accumulation dates were not put on the labels of hazardous waste.
