**COMMENTS:** In a compliance inspection conducted on 09/26/2011, AQD staff (E.Susky) observed activities at Mayfair Cleaners. The facility has one PERC dry-cleaning machine. Mr. Omailey (owner) was not present during the inspection. The facility keeps good record-keeping and utilizes the FDEP dry-cleaning calendar (all PERC rolling totals and leak checks are reflected on the calendar). The spotting board has metal plating beneath it and and beside it. The drums of hazardous waste were stored in secondary containment, however AQD staff was unable to observe the labeling for the drums
