COMMENTS: In a compliance inspection conducted on 3/26/2012, AQD staff (E.Susky) observed operations at Mayfair Cleaners. The facility has one PERC dry-cleaner. The owner was not present, however one worker was on-site. The housekeeping was good. The facility utilized its FDEP dry-cleaning calendar. However, the facility did not have its accumulation start dates on the drums of hazardous waste.
