One of the containers was overfilled and could not be closed at the time of the inspection. A verbal compliance assistance offer was made at the time of the inspection. Section V.6 Thelma Mayes was able to describe startup/shutdown/malfunction procedures. However, it could not be determined at the time of the inspection whether the owner's manuals and S/S/M plans are maintained for both machines.					
Section VI, Leak Detection and Repair, could not be determined at the time of the inspection. Wes Jacobs was not available (out having surgery) and Bettye Jacobs did not know where the halogen detector is kept.					
The facility was verbally notified that the containers need to be closed and tightly sealed. A followup inspection will be conducted when Wes Jacobs returns (sometime after $1/27/2014$).					

A hazardous waste inspection was also conducted and will be addressed in a separate report.
