COMMENTS: Carbon filter changed after every 4000 lbs. of clothing loaded into the machine. Temperatures were recorded at the end of the dry cycles. The Realstar machine reached a temperature of -4C and the Renzacci machine reached a temperature of 5C. The machines were installed in 1990.
