COMMENTS: In a compliance inspection conducted on 12/8/2011, AQD staff (E.Susky) observed operations at The Dry Cleaner located at 3097 NW 62nd St., Fort Lauderdale, FL 33309. Mr. Maurad (owner) was present during the inspection. The facility has one PERC dry-cleaning machine. He keeps excellent records and had his FDEP dry-cleaning calendar, MSDS sheets and PERC receipts available. His drums of hazardous waste were in secondary containment, but he did not have his accumulation start date on them.
