COMMENTS: The facility provided all the records and was found to be in compliance with their air permit for the inspection that was conducted on this date. The dry cleaning machine was not operating at the time of the inspection. A halogen leak detector is being used by the facility to comply with the EPA requirement. The perchloroethylene hazardous waste container was labeled, but no date was documented on the label. The waste container for the muck cookers did not have a lid. The inspector checked the machine for leaks using EPD's halogen leak detector. No perchloroethylene vapors were found.
