Facility failed to notify the Department 30 days prior to dry-dry machine installation on April 15, 2009 of the change of status. The facility's status changed from a large area source to a new small area source. The highest total perc usage decreased from 158.9 gallons/yr (Nov, 08') to 23.8 gallons/yr (Nov, 09') [jm]
