COMMENTS: Inspection conducted to verify temperature of refrigerated condensor exhaust was reading 7.5 degrees C/45 degrees F on the front gauges of the dry cleaning machine during operation. Inspection revealed the temperature at the end of the cooldown period of the dry cleaning cycle to be approximately 10 degrees C/50 degrees F which is above the required temperature of 7.5 degrees C/45 degrees F as specified in the facilty's Air General Permit.
