**COMMENTS:** In a compliance inspection conducted on 02/20/2007, AQD staff observed activities at Dry Clean USA (SAQUIB, INC.) @ 3204 W. Commercial Blvd., Tamarac, FL 33009. The facility has one PERC dry-cleaning machine. Mr. Hussein Bedi (owner) accompanied staff during the inspection. Mr. Bedi is keeping accurate records (utilizing the DEP calendar) of his temperature readings for the chiller/condenser. However, Mr. Bedi did not have epoxy around his machine or capping on his drums. These issues were refereed to Pollution Prevention/Haz-materials.

Mr. Bedi had his waste manifests and PERC receipts on-site.
