COMMENTS: I met with Mr. Joe Patel on 12/13/12, at 7:55am and the facility was in operation at the time of inspection. Mr. Patel does his dry cleaning operation at night starting at 1:00am and working until 9:00am in the morning. Mr. Patel demonstrated how he uses his leak detector for leaks and gave me a walk through of his facility. Review of his log book showed and average of 42-38 degrees in his Condenser temperature at the time of inspection. After a review of records and a tour of the facility I have found no violations to be noted at the time of inspection.
