COMMENTS: In a compliance inspection conducted on 08/31/2011, AQD staff (E.Susky) observed operations at The Dry Cleaner located @ 2422 University Drive, Sunrise, FL. Mr. Jean Walson (owner) accompanied staff on the inspection. The facility has metal plating underneath the spotting board, against the wall near the spotting board and in front of the PERC machine. Mr. Walson keeps excellent records and utilizes his FDEP PERC dry-cleaning calendar. He also has his PERC receipts and waste manifests on-site. This drums of hazardous waste were stored in secondary containment, but the area around the drums was cluttered. He also did not have his accumulation start dates on the drums of hazardous waste. Mr. Walson utilizes a PERC sniffer to check for leaks and he demonstrated it for AQD staff. His Rema vacuum also had proper secondary containment.
