COMMENTS: In a compliance inspection conducted on 10/25/2010, AQD staff (E.Susky) observed operations at M and J Dry Cleaners. Mr. Charles Joachim was present for the inspection. Mr. Joachim stated that his father had passed away within the last 8 months and they had been operating the facility as a drop store. AQD staff let Mr. Joachim know that if they still had the dry-cleaning machine on-site they would still need a hazardous materials license. The PERC dry-cleaning machine is still on-site, however it is evident that it is not currently in use. The FDEP dry-cleaning calendar was being utilized until Mr. Joachim's father passed away. The spotting board is not linked into the rest of the operations and it is evident that it is not in use. The facility did not have their waste manifests, or Material Safety Data Sheets (MSDS) on-site. The hazardous materials drum storage area had a lot of clutter in it and drums of hazardous waste were stored on top of one another. The drums of hazardous waste were not properly labeled and locking rings were not installed.
