COMMENTS: ON DECEMBER 11, 2007 I VISITED THIS FACILITY TO CONDUCT THE ANNUAL COMPLIANCE INSPECTION. ON SITE I MET ALEX LOPEZ, THE OWNER OF THE FACILITY. THE DRY CLEANING MACHINE WAS OUT OF SERVICE FOR 3 MONTHS, BUT THE OWNER DID INTEND ON FIXING THE MACHINE. UNTIL THE MACHINE IS REPAIREDTHE FACILITY IS A DROP STORE. ALL RECORDS WERE AVAILABLE AND THERE WERE NO LEAKS IN THE DRY CLEANING MACHINE. THE 12 MONTH TOTAL OF PERC PURCHASED WAS 40 GALLONS.
