**COMMENTS:** Mr. Fred Wiley met me at the facility and provided me with all the requested records. He demonstrated the Inficon TCK-Mate halogen leak detector and I reviewed his leak inspection log. The dry cleaning machine was not in operation at the time of this inspection. According to the facility records Nifty Cleaners purchased 59.75 gallons of Perc. this year.
