I explained the permit requirements and conditions to Mr. Suarez. And he intends to keep the Dry Cleaning Machine on site, although the machine is inactive. Currently the facility is operating as a drop store. An FNOV was issued for (1) No Entitlement, No IW5 & Air Permit (2) Floor around the Dry Cleaning Machine is not sealed (3) Liquid waste needs to be disposed.
