COMMENTS: The facility has one Multimatic SL50 perc dry cleaning machine (2004). During the inspection, the machine was exceeding the 45 F maximum condenser exhaust temperature. It appeared that the evaporator was not cooling properly, which could have lead to the condenser temperature issue. I informed Yasmin of the problem and she immediately called the mechanic to have it looked at. Jessica Lopez requested spin filter sludge waste manifests and told Yasmin that the floor needed to be re-sealed in certain areas to be in compliance with the regulations. I informed Yasmin that the AGP would expire on 10/26/11 and that it would need to be renewed prior to expiration. No leaks were found while using the perc leak detector. I recommend afollow-up inspection once the issues have been resolved.
