COMMENTS: In a compliance inspection conducted on 08/13/2014, AQD staff observed operations at Fashion Cleaners. Mr. Brent Cantville accompanied staff on the inspection. The facility has one PERC dry-cleaner and one Petroleum dry-cleaner. The facility housekeeping is excellent and the drums of hazardous waste were observed in proper containment and properly labeled. Mr.Cantville utilizes his FDEP dry-cleaning calendar for his PERC machine. He also had his waste manifests available for review. He was given and environmental compliance sticker per the pilot program initiated by Robert Wong (AQD).
