COMMENTS: In a compliance inspection conducted on 07/26/2011, AQD staff (E.Susky) observed operations at Nu Look Dry Cleaners (located @ 4306 Federal Highway, Fort Lauderdale). The facility operates one PERC dry-cleaning machine. Housekeeping was excellent. The drycleaning machine had epoxy around it as well as the spotting board. Drums of hazardous materials were properly contained and properly labeled. All spotting chemicals were kept in secondary containment and the Rema vacuum was in secondary containment. Mr. Park keeps excellent records and utilizes his FDEP dry-cleaning calendar as well as keeping all his waste manifests and PERC receipts on-site.

However, he did not have a PERC leak detector on-site and his entitlement has expired (separate WN will be isued).
