COMMENTS: In a compliance inspection conducted on 7/30/2013, AQD staff (E.Susky) oberved operations at Nu Look Cleaners. The facility has a new owner (Tejas Patel). Mr. Patel has owned the facility for a few months. The facility has one PERC dry-cleaning machine with epoxy around it. The spotting board also had epoxy around it. Mr. Patel did not have his PERC receipts, waste manifests, or dry-cleaning calendar on-site. He will need to apply for his Hazardous Material license and apply for his Air General Permit.
