<b>COMMENTS:</b> In a compliance inspection conducted on 8/14/2012, AQD staff (E.Susky) observed operations at French Connnection Dry Cleaners. The facility has one PERC dry-cleaning machine. The owner was not present for the inspection and findings were reported by staff to her daughter. The spotting board area had epoxy paint beneath it and the dry-cleaning machine had epoxy around it. The drums of hazardous waste were observed in secondary containment, however the drums did not have the locking rings around it. The REMA vacuum had secondary containment around it. The owner had the FDEP dry-cleaning calendar						

filled out up to February, 2012.
