COMMENTS: On November 18, 2009 I visited this facility to conduct an annual compliance inspection. On site I met Mr. Jorge Ferret, thr owner of the facility. According to Mr. Ferret, the dry cleaning machine has been out of order for past eight months and no perk was used during that time. However, no leaks were detected. Halogen leak detector was available.
