COMMENTS: Ilka Bundy, AQM Inspector, and Larry Ross, Multi Media inspector, met with Sarik Patel, owner of Ambassador Cleaners, on January 10, 2013, to conduct an inspection for the air general permit and hazardous waste management. This facility used to have Chirag Amin as the responsible official (R.O.), per the records review conducted before the inspection. Mr. Patel bought out Mr. Amin about two and a half years ago. Mr. Patel got rid of the perc dry cleaning machine a year and a half ago and replaced it with a petroleum dry cleaning machine. The new solvent, K4, is not regulated per the air general permit. The facility will be inactivated in the State's database (ARMS).
