COMMENTS: In a compliance inspection conducted on 05/31/2011, AQD staff observed operations at Sunset Cleaners. The facilityhas one PERC dry-cleaning machine. The spotting board had proper containment (metal plate) underneath it, the Rema vacuum had containment around it, and the drums of hazardous waste had proper containment. However, the drums did not have proper labeling. Mrs. Khan was available for the inspection, however her husband was off-site. He is the individual who keeps the records for the leak checks, rolling perc totals, and the temperature checks. They were not available during the inspection.
