COMMENTS: This facility no longer has a machine that uses perc, they have a new machine that uses hydrocarbons. The last time perc was purchased was in July 2012. The new machine was put in place sometime in August 2012. I met with Mr. Gun Chung on 9/26/13 and the facility was in operation at the time of inspection. After a walk through of the facility and a review of records, I have observed no violations to be noted at this time.
