COMMENTS: Atlas only produced 4 new boats last year and no boats so far in 2014. They used 5,234 pounds total gelcoat. and resin in the past 12 months. Atlas also purchased 1,443 pounds of acetone in last 12 months. The facility uses an excel spreadsheet to track purchases. The totals were incorrect but the data was accurate and matched purchase receipts. Atlas distills spent acetone for reuse.
