**COMMENTS:** In a compliance inspection conducted on 3/26/2008, AQD staff observed operations at Cable Marine W. The facility has four on-water painting slips, paint shed, boat yard, boat storage and offices. AQD staff was accompanied by Gary Strum (Yard Manager). The facility practices good BMP's on its on-water slips( boomed and tarped around vessel) and the housekeeping in the boat yard was better than previous years.

The facility also has haz-mat storage in the west shed and proper containment was observed.

AQD staff then spoke with Kellie Milligan in the corporate office and she is in the process of emailing the finalized VOC records.
