The facility makes imitation coral and landscapes for large upscale aquariums. The facility has two spray booths that are well maintained, only one is used for polyester resin. Mr. Mat Roy accompanied AQD staff on the inspection. The facility has excellent housekeeping and the ventilation system is excellent. Mr. Roy stated that the employee that keeps all the resin/polyester records was on vacation during the inspection. Records will be sent. AQD staff let Mr. Roy know that they should also include VOC records for the small amount of painting they do.
