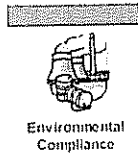

COMMENTS: THIS FACILITY HAS THREE (3) SILOS WITH INDIVIDUAL DUST COLLECTORS. THE WEIGH HOPPER HAS IT'S OWN DUST COLLECTOR. ONE SMALLER SILO IS USED FOR JOB MIX (THE CEMENT IS TAKEN DRY AND MIX AT THE JOB SITE). THE WEIGH HOPPER DUST COLLECTOR WAS TESTED FIRST. THE TEST STARTED AT 9:10 AM. THE SILO #1 WAS TESTED NEXT. THE TEST STARTED AT 9:44 AM. THE SILO WAS LOADED WITH MORE THAN 25 TON PER HOUR OF CEMENT AT 10 PSI.
