COMMENTS: PERC purchase receipts for the months of March, October, November, and December 2006 were not available at the facility, and may be at the other facility in Naples. Copies of these receipts will be faxed to the Department South District's office. Also temperature checks for the last six months of 2006 were not being read correctly by one of the workers. Temperature of the condenser was being read at about the same time every week whether the machine was in operation or not and annotated on the DEP compliance calendar at a constant 45 degrees F. Also this temperature was not being read after the appropriate cooldown period for the condenser while the dry cleaning machine was in operation.
