**COMMENTS:** In a compliance inspection conducted on 10/19/2011, AQD staff (E.Susky) observed operations at Sawgrass Ford. The facility has four prep stations, three automotive spray booths and a haz-mat area. Mr. Bill Condron accompanied staff on the inspection. The housekeeping was excellent and Mr. Condron also showed staff the facilities efforts to recycle plastics and metals. Mr. Condron emailed the department his VOC records and his VOC/lbs/day is approximately 25.45 (averaging 12 months). The facility is below their threshold for a the surface coating general permit.
