**COMMENTS:** Spray bars are not used on this equipment at this site. Mr. Danny Cavanaugh of Dixie Lime and Stone escorted me by vehicle from the scale house to the crushing location. Mr. Cavanaugh, plant manager, answered checklist questions. The facility does use water trucks to mitigate/reduce fugitive particulate of roadways. No visible emissions exceeding the Subpart OOO limits for this facility were observed from the crusher unit during my site visit. Additionally, facility equipment #2818 was not operating on this day. When asked about fuel records, Mr. Cavanaugh stated that the fuel delivery tickets and total fuel usage information is kept at the facility's main office in Ocala, FL. Photos were taken of Cedar Rapids unit and the screening equipment identified as 2818.
