**COMMENTS:** In a compliance inspection conducted on 4/9/2009, AQD staff observed activities at New River Marina. The facility is a boat yard that conducts bottom painting and some repairs. Mr. Ed Walsh accompanied AQD staff on the inspection and stated that the facility was in the process of changing ownership. Mr. Walsh was informed that he would need to fill out a new general permit application (which was emailed to him) before the ownership change.

Housekeeping was o.k. The facility did have some resin on-site as well as paints. Mr. Walsh was informed to include this in his record-keeping. He stated that the resin was utilized for small repairs. As he is a new manager, Mr. Walsh requested copies of the VOC records submitted in 2008 and that was mailed to him.
