**COMMENTS:** VE was performed at the facility on 1/19/2010. EU-001 was tested. Opacity observed was 0%, with a loading rate of 21.9 TPH, which is acceptable. The facility's roads were noticeably wet. No uncontrolled emissions were observed leaving the property. No objectionable odors were detected.
