Facility needs to ensure that all containers or buckets of gelcoat, resin, and solvent when not in use are covered or closed in order to prevent any discharge of air pollutants that could cause objectionable odors to leave the site. Facility also will be submitting a renewal air general permit before the permit expiration date of May 2, 2014. Facility's resin & gelcoat totals for the last 12 month period was 22,439 lbs.
