

COMMENTS:

I met with Will Collins, Plant Operator.

No batch trucks were being loaded. However a supply truck was loading the middle concrete silo. No excess emissions were noted. The inner batch droppoint "boot" needed some repair (some material was torn away). An outer curtain was present. The batching operation had a dedicated baghouse, the silos had individual filter units. No changes in equipment were noted.

The vehicle traffic was making some yard dust emissions. The facility staff claimed they had installed sprinklers, but they get run over by the trucks.

Periodically a front end loader pushes accumulation of yard dust, etc. into the wash out.

Department records show last compliance test on 5/01/2008.

Recommendations:

The facility needs to use more precautions to control yard dust emissions.
