COMMENTS: In a compliance inspection conducted on 07/31/2009, AQD staff observed activities at International Dry Cleaners. Mr. Vartkes (Ara) Tokatlian accompanied staff on the inspection. The facility has one PERC dry cleaning machine and it is a equipped with a temperature gauge for the condenser. Mr. Tokatlian keeps accurate records of temperatures and has PERC receipts and manifests on-site.

However, the O/W separator was not operating properly during the visit.

AQD staff then spoke with Nick Kontax (EPDGM/PPRAQD) with regards to the improper draining of the liquid (to a drum) from the separator. Mr, Kontax stated that this would have to be corrected.

On 08/14/2009, AQD staff then spoke to Mr. Tokatlian about the separator and he stated it had been repaired. A follow-up inspection was then scheduled to observe the repairs.
