I went to an area that was still under construction. The area had two new silos erected, with filter units on top, and a central mixing batcher. No batch-point baghouse appeared to be present. The facility appears to have pre-mixed concrete equipment so the facility does not appear to need batch trucks.

The facility did not appear to be in operation.

Afterwards I met with Leanne Moorehead, QC manager. Ms. Moorhead explained that the batch operation was to start up in approximately two weeks.

I gave her a copy of the registration form that contains the compliance testing rule and I also informed her of the 15 day notification period that is required for compliance testing. The rule is as follows:

Rule 62-297.310(7)( a)9, Florida Administrative Code, states:

The owner or operator shall notify the department, at least 15 days prior to the date on which each formal compliance test is to begin, of the date, time, and place of each such test, and the test contact person who will be responsible for coordinating and having such test conducted for the owner or operator.

Note: Some items on the checklist could not be completed due to the following: insufficient information, testing not yet performed, and the facility is not yet operational.
