COMMENTS: Conducted inspection with Shawn Kirby, Maintenance Supervisor. Reviewed VOC usage records, April 2011 was 11.53 lbs/day VOC averaged. Paint booth intake and exhaust filters are replaced weekly. Exhaust filters were double layered. A contractor collects the used acetone and rags. Minimal paint gun cleaning is required, as each gun is designated a specific color. Paint containers are used until empty, which minimizes left over paint. A contractor delivers and manages the paint supply. No odors were noticed on or off site.
