

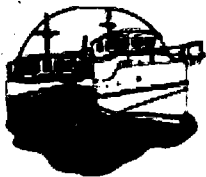

The company operates on a normal work week/40 hours. There are no air pollution control equipment.
